MANAGER'S REPORT

To all Members and their guests,

The temperatures continue to rise, and children are looking for activities to prevent their summer boredom. Based on those facts, I would like to remind everyone to read through the Association's Rules and Regulations put in place for everyone to be able to enjoy the Amenities safely. We are glad to see the Amenities being utilized, but 3 of the rules that I see being an issue this year are: General Rule #7 while on the grounds, children under the age of 10 y.o. shall be accompanied by a person who is 16 y.o. or older, with a maximum of 3 children in their care. Swimming Pool Rules #5 absolutely no food or drinks in the pool, on the edge of the pool or within 4 feet of the pool. Swimming Pool Rules #10 Children must be 13 v.o. to use the pool without supervision, and anyone under the age of 13 must be accompanied by someone 16 y.o. or older with a limit of 3 children in their care. Another issue that has been brought to my attention is the swimming pool rules is when the pool needs to be closed. Our signs state at dusk, but per the published rules by the Florida State Department of Health, our pool has to follow the commercial pool rules, and without the installation of lighting in the pool and on poles around the pool to provide the required number of lumens without causing glare, the pool must be closed one ½ hour before sunset. Currently that is just short of 8 pm. New signs are being printed and will be posted once completed. Please remember, you

must have your membership ID on you and display it when asked in order to utilize the Association property or you will be asked to leave.

To all homeowners, and renters, who take care and pride of their property, the Architectural Board wants to say THANK YOU to each of you who work so hard to keep your property looking beautiful. It is a great pleasure to see manicured lawns and maintained landscaping. The negative side of spring, with the rain and sunshine, is everything grows so fast. This means that yard maintenance needs to be kept up, usually on a weekly basis.

We would like to remind all the property owners that **external** changes to your property usually require a **Modification Request form**. Adding or changing: fence, painting, installing a new roof, adding solar panels, a new pool, lanai, shed, or driveway alteration, or removing trees, you will need approval from the Architectural Board before you begin the project. Many items may require a Pasco County Permit. The best policy is to ask first. This action can save you time and money in the long run. The Modification Requests are available at the office, or via email.

The Architectural Board function is to maintain the high standards set for Lake Padgett Estates East Property Owners Association. The Violation notices you may receive are sent to remind you of the standards that have been set and ask you to accept these letters as a positive effort to maintain the beauty and aesthetics of our neighborhood. The Violation letters are ruled by the DCR's and Florida State Statute, Chapters 718 and 720.


