From the Architectural Board NOTICE TO ALL HOMEOWNERS

During the last several months many homeowners have been updating their homes with new roofs, windows, painting and landscaping. Still, many homeowners are unaware of Violations and the DCRs. The following are a partial list per the Declaration of Covenants, Conditions and Restrictions for LPEE. Although this is not a complete list, these are the violations that are most numerous and common. You can find a complete list in your copy of DCR's, or on line at <u>lakepadgetteast.com</u> and go to Forms & Documents.

- All trash cans shall be screened from view from any street in the subdivision. These need to be behind a fenced area, or in the garage.
- Boats, boat trailers, other types of trailers, campers and any other such vehicle shall not be permitted to stay on a lot unless enclosed in a garage or screened from view with fencing from adjoining lots, streets or common areas.
- Exterior of your home and lot shall be maintained in a neat and attractive manner. This shall include, but not limited to, lot maintenance, repairing, replacing or painting fencing, mildew removal, painting your home with approved colors, roofing, gutters, mildew/mold removal from mail boxes, your home, fences, and driveways. Many of these may require a Pasco County Permit.
- Certain exterior modifications for your property must have an Exterior Modification Form completed and the form and fees turned into the office so that it can be approved at the next Architectural Board meeting. You can print this form from lakepadgetteast.com in the Forms and Documents section.


